

### CBD COP15 related decisions




- ➤ Kunming-Montreal Global Biodiversity Framework (CBD/COP/DEC/15/4)
  - 2050 Vision, 2030 mission, 4 Goals, 23 Targets, other important sections.
- ➤ Monitoring Framework (CBD/COP/DEC/15/5)
  - Four groups of indicators (Headline, global binary, component, complementary)
  - Establishment of Ad Hoc Technical Expert Group (AHTEG) on Indicators
- Mechanisms for planning, monitoring, reporting and review (CBD/COP/DEC/15/6)
  - Adoption of "an enhanced multidimensional approach to planning, monitoring, reporting and review" comprising of the following;
    - (a) NBSAPs revised or updated by COP16
    - (b) National reports submitted in 2026 and 2029
    - (c) Global Analysis of information in NBSAPs at COP16 and following COPs
    - (d) Global review of collective progress
    - (e) Voluntary peer reviews
    - (f) Open-ended forum for voluntary county reviews
    - (g) Information on non-State actor commitments
