ESABII Training of Trainers (ToT) on CITES Policies and Identification of Threatened Species

East and Southeast Asia Biodiversity Information Initiative (ESABII) was launched to pursue capacity building in taxonomy and the development of an information system on biodiversity in East and Southeast Asia in order to contribute to the promotion of biodiversity conservation and the implementation of the CBD (Convention on Biological Diversity) Strategic Plan in the area.

ESABII offers training course for government officials from ASEAN and Mongolia. As one of the activities of ESABII held annually, we put focus on:

- increase awareness of illegal wildlife trade and the importance of proper control, based on CITES regulations
- provide skills and knowledge for identification of wildlife species.
- build capacity to be the trainers for colleagues in respective country on the wildlife trade, CITES and domestic laws and policies
- build effective network and make life-long friends across ASEAN and Mongolia
